V. Public Testimony

Individuals interested in signing up to provide oral testimony at the meeting may submit their name, email, and phone number to reapportionment@hawaii.gov. Individuals may provide oral testimony at the meeting via the above-listed video conferencing link or by calling in to the above-listed telephone number.

Testimony presented during the meeting will be limited to three minutes each.

VI. Adjournment

If audiovisual communication cannot be maintained with all Council members participating in the meeting, the meeting shall be automatically recessed for up to thirty (30) minutes to allow staff to attempt to restore communication. If audiovisual communication with all participating Council members can be restored, the meeting will be reconvened. If, however, audiovisual communication cannot be restored, the meeting will be reconvened with the audio-only communication using the above-listed telephone number and any nonconfidential visual aids brought to the meeting by Council members or as part of a scheduled presentation will be made publicly available on the Office of Elections website within fifteen (15) minutes after audio-only communication is established. No Council action shall be invalid if the Council's good faith efforts to implement remote technology for public observations and comments do not work.
