Mr. Hull: Before I turn it over to the Subdivision Planner, let me ask if there's any members of the public that would like to testify on this agenda item? We have no one signed up. Seeing none, I'll turn it over to the planner for the report pertaining to the matter.

<u>Staff Planner Kenny Estes:</u> I'll summarize the report for the record.

Mr. Estes read the Subdivision Report for the record (on file with the Planning Department).

Mr. Estes: Chair, the department has received a correspondence from the applicant requesting a 6-month deferral of Preliminary Subdivision Map Approval as a result of comments received from the Department of Public Works Engineering Division. This report was transmitted to the Planning Commission through Supplement Report No. 1 to the Subdivision Report. The applicant has also agreed to waive the 45-day timeline for the Planning Commission to act on the subdivision, pursuant to Section 9-3.4 of the Subdivision Ordinance, Kaua'i County code. With the applicants consent, the department is requesting a deferral of this application to the Planning Commission meeting that will be held on June 10, 2025, or the next available Planning Commission meeting thereafter.

<u>Vice Chair Ako:</u> Okay. Thank you, Mr. Estes. Any questions for staff? Would the applicant like to add?

Ms. Maren Arismendez: Good morning. Maren Arismendez from Esaki Surveying, here on behalf of the owners. We would like to respectfully request a 6-month deferral. The time is to be used by the owner to discuss with Public Works the proposed projects that they have for the adjacent area and how the Sueko Store expansion will be affected or how both projects can work together, so we're just trying to get on the same page, the owners and Public Works. They are also wanting to update the various permits that were listed as a condition, so we just thought it was in the best interest to make sure that we can submit at least a request for those permit updates, so that Planning Commission and county has the full picture of what the project is currently.

<u>Vice Chair Ako:</u> Questions? So, we're looking at June 10, 2025, and with the waiver of the 45 days...

Ms. Arismendez: Yes.

<u>Vice Chair Ako:</u> ...(inaudible).

Mr. Hull: But then I'll just say, definitely by all means we're in support of you working with Public Works to resolve and go over their circulation concerns. Concerning the updates to the zoning permits, your client absolutely has the ability to do that and come before the commission. I can also, just to put on your radar, since the approval of those permits back in like, 2015, the South Kaua'i Community Plan was updated and that some of your proposed expansion (inaudible) can be folded under those Class IV Zoning Permits, but they also can potentially be folded within the Form Based Code under Class I Zoning Permit, so you might also want to take time to meet with staff to go over the Form Based Code potential processes.

Ms. Arismendez: Okay. Thank you.

Vice Chair Ako: Okay, if not, thank you. So, if not, I'll entertain a motion to defer.

Mr. Ornellas: I move to defer Subdivision Application S-2025-1 for a period of 6-months or until scheduled by the department.

Mr. Ako: I'll second. Anything else? If not, Mr. Clerk, if we can have a roll call vote on this.

Mr. Hull: Roll call, Mr. Chair. Commissioner Ornellas?

Mr. Ornellas: Aye.

Mr. Hull: Chair Ako?
