	Patrol Services Officers Daniel Ball, Ian Cowden, and Christian Kaui were nominated as the Kaua'i Police Department's Employees of the Month for March 2024.	
	Lt. Perreira noted that since Officer Cowden was no longer with KPD and had recently accepted a position with another Police Department on the mainland, she would like to recognize him first for his service. On December 29, 2023, at approximately 1931 hours, Officer Cowden responded to a medical call of two male subjects who were passed out. Upon his arrival on the scene, he observed one of the males not breathing and was receiving CPR. The second male was located at the rear of the residence and had already been identified as having been given one dose

DISCUSSION	of Narcan and was in the middle of receiving CPR. Officer Cowden took immediate action and administered a second dose of Narcan immediately following the use of an ADB which provided critical support until additional medical help arrived. Officer Cowden's decisive actions and ability to remain calm played a major role in saving the life of the male subject from a potential overdose. In addition to the incident, Officer Cowden consistently exhibits qualities that make him an invaluable member of the team and the honor of being named the Kaua'i Police Department Employee of the Month.	Chair Yoshida expressed the Police Commission's gratitude to Officer Cowden for heroically saving the life of the male.	There being no further comments, Lt. Perriera continued the recognition for March 2024 employees of the month.	On February 27, 2024, at 1430 hours, Officers Ball and Cowden responded to a residence in the Waipouli area for a distress call involving a 51-year-old female who was found unresponsive and suspected of a possible fentanyl overdose.  First responders responded to a medical emergency and upon their arrival, the first responders found an acquaintance performing CPR on the woman, but efforts were proving to be unsuccessful. Officer Daniel Ball arrived first on the scene and noticed that the woman was suffering from an opioid overdose. He immediately gave the woman one dose of Naloxone however, there was little improvement to her condition. Shortly, Officer Kaui arrived at the scene and quickly administered a second dose of Naloxone to the woman. She regained consciousness and was taken to Wilcox Memorial Hospital for treatment.	After the commendation was read, each commissioner took the opportunity to

As opioid-related overdose deaths continue to rise, changes in the role of law enforcement officers have included being trained to administer naloxone to reverse overdoses. Officers Ball, Cowden, and Kaui are hailed as heroes after saving the lives of the three individuals.	There being no further comments, Chair Yoshida called for public testimony.	Councilmember and Public Safety Committee Chair Felicia Cowden expressed her gratitude to all three officers. She stated that it breaks her heart to hear that it is happening on Kaua'i. She also expressed deep concern about the risks and dangers the officers take and face when they encounter people who are exposed to those drugs. She shared that she keeps Narcan in her car and that Malama Pono distributes Narcan to the public. She shared a statement from her son Officer lan Cowden he sent to her via text message. Ian joined the Kaua'i Police Department in 2021 because he wanted to make a difference in the community he was born and raised in. He went on to say that watching the news coverage all he saw was the negative perception of police officers so he told himself that if he could show just one person that police officers are there to help, then he has fulfilled his dreams. He is thankful for the Kaua'i Police Department, a force that always strives to make a positive impact on the community, and he is hopeful for the future. Therefore, it is his honor and privilege to introduce and recognize KPD's 911 dispatchers to the Police Commission and the audience.	Commissioner Hertog stated that it takes an incredibly special person to do the job they do because she couldn't. They are the first line of defense, passing on information that officers need to know before entering a situation. She was grateful for the dispatchers' patience, courage, and kindness, and hoped that the Department fill the vacancies to make their job easier and to help them distress.	Commissioner Knutson agreed with Commissioner Hertog's sentiment about the challenges of the dispatchers' daily work, especially her comment about not being able to do the difficult work they do. She shared that she volunteered to work in a similar type of position and she couldn't do it.	Commissioner Belz mentioned that she recently had an encounter with a dispatcher. She found the person on the call to be incredibly calming and expressed that dispatchers are the unsung heroes of first response. # **MAJOR HIGHLIGHTS**

# Felony Family Abuse

On April 1, 2024, officers responded to Hanamaulu for a report of a male assaulting his girlfriend. The victim, 35-year-old female resident, reported to officers that her boyfriend assaulted her and attempted to strangler her. Upon officers arrival to the scene, the suspect barricaded himself in the bathroom while armed with a knife. KPD Crisis Negotiators responded to the scene and eventually got the suspect to exit the bathroom at which time he was taken into custody without incident. The suspect was transported to Wilcox Memorial Hospital for a physical and mental health evaluation. Based on the evaluation, the suspect was treated at the Mahelona Psyche Ward and later transported back to KPD custody. The suspect was held pending bail. CID was notified.

# Robbery

On April 2, 2024, officers responded to an encampment located near the Lihue Water Department for a reported robbery. The victim, a 52-year-old male resident, reported to officers that he was asleep in his tent when he was assaulted by the suspect who was armed with a stick. After assaulting the victim, the suspect fled with the victim's backpack. The victim was transported by medics to Wilcox Memorial Hospital and treated for non-life-threatening injuries. The suspect was identified as a 40-year-old resident and was taken into custody without incident. Officers recovered the stolen backpack and returned it to the victim. The suspect was held pending bail. CID was notified.

# Assault 1st

On April 8, 2024, officers responded to Hanamaulu for a report of a male who had been shot in the chest. The victim reported to officers that he was in an argument with a 53-year-old male resident when the individual pointed a firearm type weapon at him. The suspect used the weapon to shoot projectiles at the victim causing injuries to the victim's chest and facial area. The victim was initially treated at Wilcox Memorial Hospital but due to the severity of his injuries, he was transported to Queens Hospital on Oahu for further treatment. CID detectives responded and took over the investigation.

# UCPV/Kidnapping:

On April 14, 2024, officers responded to a gas station in Kapaa of a reported male subject swinging a knife at someone. Upon officer's arrival, the investigation revealed that the parties involved were in a domestic dispute that led to the brandishing of a machete, as well as a mutual assault of two male subjects. During the altercation, one of the male subjects entered the driver's side of the other male subject's vehicle and prevented a female passenger/victim from leaving then drove off with the vehicle. CID detectives were notified and responded to the scene for continued investigation.

#### Misc. Pub. Hazard

On Thursday, April 18, 2024, at approximately 1843 hours, a large tree fell on Maluhia Road near the S-Turns, causing a total road closure. By 1856 hours, Maluhia Road was closed in both directions, and Public Works was notified. Prior to the arrival of Public Works personnel, a good Samaritan helped cut a small portion of the tree. This allowed a partial reopening of the northbound lane of Maluhia Road. However, due to the continuous hazardous conditions, it was decided to keep the southbound lane closed and divert motorists onto Omao Road. At approximately 2102 hours, Public Works arrived on the scene and began clearing the debris. During this process, additional equipment was required due to the possibility of another tree falling and the discovery of a mini landslide. At approximately 2225 hours, the Department of Public Works requested closure of both directions of Maluhia Road. Workers estimated that approximately two additional hours were needed to clear the debris and ensure no further tree-related hazards.

# Misc. pub. hazard

On Tuesday, April 23, 2024, at approximately 1623 hours, KPD dispatch received numerous calls about a utility pole down on Hoomau Road. Upon officers' arrival, they found a utility pole had fallen, blocking the entire road at 7951 Hoomau Road. Wires were on the ground, causing a nearby utility pole to bend under the weight of the fallen pole. Hoomau Road was closed from Amakihi Road to Akialoa Road, and Akekeke Road was also closed from Elepaio Road to Iwipolena Road while KIUC personnel repaired the downed utility poles. The entire block on Hoomau Road from Akialoa Road to Amakihi Road was temporarily left without power. No injuries were reported.

# Traffic collision involving injury

On April 25, 2024, officers responded to a traffic collision involving a pedestrian fronting a residence in Koloa. An adult female, aged 72, of Koloa, was walking eastbound on Wailaau Rd when she was struck by a vehicle that fled the scene. The victim was transported to Wilcox ER in critical condition. The ER doctor reported that the victim sustained a collapsed lung, brain bleed, and other non-life-threatening injuries. The Traffic Safety Section was notified and was monitoring the investigation. Checks were made in the surrounding areas for the suspect vehicle with negative results.

# Unauthorized Entry into a Motorized Vehicle

On April 29, 2024, officers responded to Lihue Airport for a report of an unauthorized male who boarded a private aircraft. The reporting party informed officers that the suspect, 39-year-old male resident, forced his way through an airport door and gained access to the tarmac. After breaching the restricted area, the suspect boarded a private aircraft at which time he was confronted by the pilot. The suspect informed the pilot that he was with the CIA and was supposed to be on the plane. The suspect has a history of drug induced delusions resulting in his arrest. The suspect was taken into custody without incident and released after posting bail.

# ATTEMPTED MURDER:

# 24-04566- Attempted Murder in the 2<sup>nd</sup> Degree

SYNOPSIS: Police arrested a suspect in connection with a shooting that occurred during the early morning hours on Monday, April 8, 2024, in a Hanamaulu neighborhood. During the incident, a 28-year-old man from Līhu'e sustained a gunshot injury and was medevacked to the Queen's Medical Center on O'ahu in serious condition. He was treated and subsequently released. The suspect was arrested and is currently being held at the KCCC.

# **NEGLIGENT HOMICIDE:**

# 24-04779- Negligent Homicide in the 2<sup>nd</sup> Degree

SYNOPSIS: During the nighttime hours on Thursday, April 11, 2024, a 56-year-old man was struck by a vehicle fronting his residence located off Kahuna Road in Kapahi. The victim was transported to Wilcox Medical Center, where he was later pronounced dead. A 43-year-old man from Kīlauea was arrested for Negligent Homicide in this case and is currently being held at the KCCC, with his bail currently set at \$500,000.

# ABUSE OF FAMILY:

Adult female reported that she was assaulted by an adult male relative during a domestic altercation that occurred at their shared residence. The adult male was later arrested, and the case was forwarded to the Office of the Prosecuting Attorney for further action.

# **ASSAULT:**

- 1. An adult female medical professional reported being assaulted by an elderly male patient at the Kapa'a medical facility. The case was forwarded to the Office of the Prosecuting Attorney for further action.
- 2. An adult male was arrested for assaulting an adult male victim during an incident that occurred in the Lihue area. The case was forwarded to the Office of the Prosecuting Attorney for further action
- 3. An adult male was arrested for assaulting his adult male relative, during a domestic altercation that occurred at a Lihue residence. The case was forwarded to the Office of the Prosecuting Attorney for further action.
- 4. A Correctional Officer reported being assaulted by an adult male inmate at KCCC. No arrest was made, and the case was forwarded to the Office of the Prosecuting Attorney.
- 5. An adult male reported being assaulted by his adult female relative during a domestic altercation that occurred near their Kapa'a shared residence. The adult female was later arrested, and the case was forwarded to the Office of the Prosecuting Attorney for further action.
- 6. Adult male victim reported being assaulted by an adult male that occurred in the Kapa'a area. No arrests were made, and the investigation remains ongoing.

#### **UNATTENDED DEATH:**

- 1. Unattended death of a 52-year-old female subject who died in her Kekaha residence. Foul play was not suspected, and the investigation remains on-going, as an autopsy was completed, but toxicology results are pending.
- 2. Unattended death of a 63-year-old female subject who died in her Koloa residence. Foul play was not suspected. An autopsy was completed, and the results indicated that the manner of death was natural.
- 3. Unattended death of a 91-year-old male subject who died in his Lihue residence. Foul play was not suspected, and the investigation remains on-going, as an autopsy is pending. An autopsy was later completed, and the results indicated that the manner of death was natural.

# MISCELLANEOUS OTHER-HUMAN REMAINS RECOVERED:

1. A 79-year-old female resident summoned police to her Lawai residence to recover a human skull that was allegedly found by her 76-year-old husband a long time ago. Foul play is not suspected and the investigation remains ongoing.

# **KIDNAPPING**

1. An adult female with no permanent address was reported to have been kidnapped by a known adult male. The scene is located at a gas station in Kapa'a, and the kidnapping incident occurred after the adult male suspect had engaged in a physical altercation with another adult male subject known to the victim.

Before leaving the scene, the adult male suspect allegedly assaulted the female victim in the vehicle. The known adult male suspect drove the female victim away from the scene and fled the area before police arrived. The adult female victim was later located. No arrests have been made, and the investigation remains ongoing.

# ROBBERY:

- Case involving an adult male with no permanent address that was allegedly assaulted and robbed
  of his personal property by an adult male subject who is known to him, during an incident that
  occurred in the vicinity of the Old Lihue Sugar Mill. The victim sustained substantial injuries and
  received emergency medical care at the Wilcox Medical Center, where he was later treated and
  released. The adult male suspect was later arrested without incident, and currently remains in
  custody at KCCC.
- Case involving two adult females with no permanent address were allegedly assaulted and robbed
  of their personal property by an adult male subject who was known to them. The incident occurred
  in the vicinity of the Lydgate Beach Park area off Nehe Rd. in Wailua. The investigation remains
  ongoing.

# **RUNAWAY JUVENILE:**

- 1. Case involving a male juvenile who was reported as a runaway on April 12, 2024. A BOLO and press release was issued, and the male juvenile later returned home and was detained and returned to his parent without incident.
- 2. Case involving a male juvenile who was reported as a runaway on April 17, 2024. A BOLO and press release was issued, and the male juvenile later returned home and was detained and returned to his parent without incident.

# **SEXUAL ASSAULT:**

 Attempted sexual assault complaint filed by an adult female who reported that an unknown male subject attempted to sexually assault her while in the Kilauea area. The investigation remains ongoing.

# UNAUTHORIZED ENTRY INTO AN AIRCRAFT/CRIMINAL PROPERTY DAMAGE:

1. Case involving a 39-year-old adult male resident, who breached and damaged a security door leading to the secured tarmac area of the Commuter Airline Terminal of the Lihue Airport, and who had forcefully boarded a private Jet.

Airport Police quickly responded to the scene and took custody of the male subject. KPD officers later arrived and took custody of the male subject, who was later booked and released after posting the required bail. The case was assigned to a Detective and the case will be forwarded to the Office of the Prosecuting Attorney.

## KAUA'I POLICE COMMISSION

Draft language for future adoption of Rule 11
Kaua'i County Police Commission Rules on Administrative Practice and
Procedure

April XX, 2024

1. Draft language for Rule 11, Kaua'i County Police Commission Rules on Administrative Practice and Procedure, is proposed for future adoption to be read as follows:

# RULE 11 COMPLAINTS AND CHARGES AGAINST THE CHIEF OF POLICE

Historical note: This rule is based substantially upon Rule 3-1(g)(6) – (7). [Eff. 2/12/18; R.

## Rule 11-1 General Information.

- a. <u>Defined</u>. As used in this rule "complaints against the chief of police" refers to complaints filed by a member of the police department or a member of the public against the chief of police for alleged inappropriate behavior or violation of police department or county policy.
- b. <u>Initial investigation process</u>. All complaints against the chief of police regardless of how they are received are initially subject to the procedures contained in the County of Kaua'i policy regarding the Discipline of Department Heads Subject to Removal by Boards and Commissions.

## Rule 11-2 <u>Complaints Filed Against the Chief of Police.</u>

- a. Written complaints against the chief of police filed with the mayor.
  - 1. This policy provides direction to the mayor and the police commission on the procedures to be followed when a complaint is filed against the chief of police.
  - Written complaints against the chief of police shall be investigated pursuant to the procedures set forth in the County of Kaua'i policy regarding the Discipline of Department Heads Subject to Removal by Boards and Commissions.
  - 3. Rule 10 shall not apply to written complaints against the chief of police filed with the mayor.
  - 4. Rule 5 hearings shall not apply to complaints filed against the chief of police pursuant to this rule.
  - 5. All complaints against the chief of police shall be in writing and filed with the mayor no later than one hundred eighty days from which the complainant becomes aware of the matter which gives rise to the complaint.
  - 6. Upon receipt of the written complaint, the mayor shall transmit the complaint to the chairperson.
  - 7. Upon receipt of the transmitted complaint, the chairperson shall schedule an executive session on the matter in compliance with state and county law.
  - 8. The police commission shall meet in executive session to review the complaint. The seriousness of the allegations shall be considered as to whether a special executive session is required or if the complaint can be discussed at the next regularly scheduled commission meeting.
  - If, after review, the police commission determines further factual information is required for a decision on the matter, the mayor shall be advised that an investigation shall be conducted.
- b. <u>Investigation procedures for written complaints against the chief of police.</u>
  - 1. The investigation may be conducted by county personnel or by an independent contractor.
  - All investigations regarding written complaints against the chief of police shall comply with applicable laws regarding personnel complaints to similarly situated appointed positions.

- 3. Upon completion of the investigation, the mayor may make a recommendation to the police commission, which may include but is not limited to, discipline, suspension, or no action.
- 4. After review of the investigation report, the police commission may request further investigation of the matter if the investigation is incomplete or if the police commission has any further questions regarding the subject matter of the investigation.
- 5. The police commission shall render its decision after duly and appropriately considering all information.
- 6. In rendering its decision, the police commission may discipline\* or remove the chief of police. Pursuant to the Charter of the County of Kaua'i, article XI, section 11.04, "the chief of police may be removed by the police commission only after being given a written statement of the charges against the chief and a hearing before the commission."

\*In Kaua'i Police Com;n ex rel. Iona v. Carvalho, 138 Hawai'i 287 (App. 2016), the Hawai'i Intermediate Court of Appeals held that the police commission's power to appoint and remove the chief of police includes the power to discipline.

- c. Written complaints against the chief of police filed with the police commission.
  - 1. Rule 10 shall not apply to written complaints against the chief of police filed with the police commission.
  - 2. Rule 5 hearings shall not apply to complaints filed against the chief of police pursuant to this rule.
  - 3. When the police commission directly receives a written complaint against the chief of police, the chairperson will advise the mayor.
  - 4. After review by the mayor and the chairperson, a determination shall be made as to whether the complaint warrants an investigation.
  - 5. If a determination is made by the mayor and chairperson that an investigation is warranted, the procedures in Rule 11-2(a) and (b) shall be followed.
- d. Non-written complaints against the chief of police.
  - 1. If the allegations of misconduct against the chief of police come to the attention of the police commission through

- other than the filing of a written complaint, the chairperson shall advise the mayor.
- 2. The mayor shall provide direction on whether the allegations are of sufficient seriousness to warrant an investigation.
- 3. If the mayor determines that no investigation is to be conducted, the chairperson shall request a written statement from the mayor to that effect.
- 4. If the mayor determines that no investigation is to be conducted based on a non-written complaint against the chief of police that was brought to the mayor's attention by the police commission, the matter shall be placed on the executive session agenda at the next police commission meeting to document the police commission's actions.
- 5. If a determination is made by the mayor that an investigation is warranted, the procedures set forth in Rule 11-2(a) and (b) shall be followed.

## Rule 11-3 Charges against the chief of police.

- a. Discipline or removal of the chief of police.
  - 1. The police commission may discipline\* or remove the chief of police pursuant to the Charter of the County of Kaua'i, article XI, section 11.04, which states that the chief of police "the chief of police may be removed by the police commission only after being given a written statement of the charges against the chief and a hearing before the commission."

\*In Kaua'i Police Com;n ex rel. Iona v. Carvalho, 138 Hawai'i 287 (App. 2016), the Hawai'i Intermediate Court of Appeals held that the police commission's power to appoint and remove the chief of police includes the power to discipline.

 The police commission shall investigate complaints against the chief of police pursuant to the procedures set forth in the County of Kaua'i policy regarding the Discipline of Department Heads Subject to Removal by Boards and Commissions.

- b. <u>Grounds for discipline or removal</u>. Grounds for discipline or removal of the chief shall include but is not limited to the following:
  - 1. Malfeasance wrongful act by a public official;
  - 2. Misfeasance wrongful exercise of law authority;
  - 3. Nonfeasance omission of an act that ought to have been performed;
  - 4. Falsification of candidate's application; and
  - 5. Conviction of any misdemeanor or felony.
- c. <u>Disciplinary procedures</u>. The police commission may institute disciplinary procedures against the chief of police upon motion of any member of the commission and a majority vote in favor thereof.
- d. <u>Disciplinary actions</u>. The police commission may sustain the allegations of any charge against the chief of police by a majority vote and may take any of the following actions:
  - 1. Reprimand the chief of police (written or verbal);
  - 2. Suspend the chief of police for a period of time to be determined by the police commission; or
  - 3. Remove the chief of police pursuant to the Charter of the County of Kaua'i, art. XI, section 11.04, after the chief of police is given a written statement of the charges against him/her and a hearing before the police commission.

This document is intended to be viewed in reference with the draft language for Rule 11, Kaua'i County Police Commission Rules on Administrative Practice and Procedure, which is being proposed for future adoption, as the draft language for the proposed Rule 11 is substantially based upon Rule 3-1(g)(6)-(7). The following was approved for future adoption by the police commission at its May 26, 2023:

## RULE 3 CONTROL, MANAGEMENT AND DIRECTION OF THE DEPARTMENT

Rule 3-1 Specific Powers, Duties and Responsibilities of the Police Commission.

<u>Public Charges Against the Conduct of the Department or Any of its Members.</u>

\* \* \*

- Complaints Filed Against the Chief of Police.
  - Written Complaints against the Chief of Police Filed with the Mayor.
    - i. County of Kaua'i Policy regarding the Discipline of Department Heads Subject to Removal by Boards and Commissions states that complaints against Department Heads who are appointed by a Board or Commissions shall be filed with the Mayor.
    - ii. This policy provides direction to the Mayor, and the Police Commission, on the procedures to be followed when a complaint is filed against the Chief of Police.
    - All such complaints filed with the Mayor shall be in writing.
    - Upon receipt of a written complaint the Mayor shall transmit said complaint to the Chairperson of the Kaua'i Police Commission.
      - The Police Commission shall meet in Executive Session to review the complaint. The seriousness of the allegations shall be considered as to whether a special Executive Session is required, or if the complaint can be discussed at the next regularly scheduled Commission meeting.
    - If, after review, the Commission determines further information is required, the Mayor shall be advised that an investigation is warranted.
    - vi. The Mayor and the Chairperson, shall determine if the complaint warrants an investigation utilizing the

process described in the County Policy Regarding
Discipline of Department Heads Subject to Removal by
Boards and Commissions or through the process
contained in the Police Commission Rules, Section 31(g), Investigation of Citizens Complaints.

- Regardless of which investigation route is followed, upon completion of the investigation the Mayor may make a recommendation to the Commission on appropriate discipline, if warranted. The Commission will consider, but shall not be bound by the Mayor's recommendation.
- vii. The Commission shall also review the investigation, and after duly considering all factual information, and the Mayor's recommendation, render a decision.
- Written Complaints Against the Chief of Police filed with the Police Commission.
  - Police Commission Rules, Section 3-1(g), describes the procedures for the filing of Public Charges against the Conduct of the Department or any of its Members through the Citizens Complaint process.
  - When the Police Commission receives a complaint against the Chief of Police in this manner the Chairperson shall advise the Mayor.
  - iii. After review by the Mayor and the Chairperson, a determination shall be made if the complaint warrants an investigation utilizing the process described in the County Policy or through the process contained in Police Commission Rules for the investigation of Citizens Complaints.
- e. Non-Written Complaints against the Chief of Police.
  - If the allegations of misconduct by the Chief of Police come to the attention of the Police Commission through other than the filing of a written complaint, the Chairperson shall advise the Mayor.
  - The Mayor shall provide direction on whether the allegations are of sufficient seriousness to warrant an investigation.
  - iii. If the Mayor determines that no investigation is to be conducted the Chairperson shall request a written statement from the Mayor to that effect.
  - iv. The fact that a non-written complaint against the Chief of Police was brought to the Mayor's attention by the Police Commission, and the Mayor declined to investigate, shall be placed on the Executive Session

Agenda at the next Commission meeting to document the Commission's actions.

## Charges against the Chief of Police

- a. It is the intent of this rule that the Chief of Police be disciplined Or dismissed only for cause and not arbitrary or capriciously. Grounds for discipline or dismissal of the Chief shall include but not limited to the following:
  - Malfeasance (Wrongful act by public official).
     Misfeasance (Wrongful exercise of law authority).
     Nonfeasance (Omission of an act that ought to have been performed).
  - 2. Falsification of candidate's application.
  - 3. Conviction of any misdemeanor of felony.
- b. The Commission may institute disciplinary procedures against the Chief upon motion of any member of this Commission and a majority vote if favor thereof. Any proceedings pertaining to charges brought against the Chief shall be considered a contested case and be conducted in accordance with Chapter 5, except that all such proceedings shall be closed to the public unless otherwise requested by the Chief.
- e. The Commission may sustain the allegations of any charge against the Chief by a majority vote and may take any of the following actions:
  - 1. Reprimand the Chief (written or verbal).
  - Suspend the Chief for a period of time determined by the Commission.
  - 3. Dismiss the Chief.]
