<b>Meeting Called to Order/Roll Call to ascertain quorum</b>	Chair Yoshida called the meeting to order at 9:00 a.m., and immediately called for a roll call to ascertain a quorum. Commissioners Calma, Hertog, Hong, Vice Chair Leslie and Chair Yoshida were present.

<p><b>Public Testimony</b></p>	<p>Chair Yoshida called for public testimony, but none was offered at this time.</p>	
<p><b>Recognition of AC Mark Ozaki as the new Deputy Police Chief effective October 1, 2024.</b></p>	<p>Commissioner Hertog commented that emailed AC (Assistant Chief) Mark Ozaki to congratulate him on being selected to be the new Deputy Police Chief for the Kauai Police Department.</p> <p>Commissioners Calma and Hong, both congratulated and expressed their support for AC Ozaki on being newly appointed to the Deputy Police Chief position.</p> <p>VC Leslie made a comment that he couldn't be happier as it was a huge issue for him that the deputy police chief's position was open for so long.</p> <p>Chair Yoshida congratulated AC Ozaki, hoping that his appointment will help to move the Department in the right direction. She then invited AC Ozaki to say a few words on being selected to the Deputy Police Chief position.</p> <p>Assistant Chief Ozaki stated that he didn't expect to be recognized by the Commission but appreciates it and is humbled by their kind words. He thanked his brothers and sisters in blue sworn, all non-sworn personnel, as well as KPD's partners sitting in the audience. He explained that the reason he accepted the Deputy Chief's position was because for the past couple of years, he was asked if he would be interested in filling the position, and each time his reply was no.</p> <p>AC Ozaki stated that originally, he planned on retiring next month, but then he decided to accept the position because he wanted to be part of the solution, not part of the problem and with the Gallup survey results it confirmed things that they had already been thinking about.</p> <p>He stated that when you give your blood, sweat, and tears to an organization</p>

	<p>and have relationships with people you care about and their families and then hear your department was ranked the lowest out of hundreds of other police departments Gallup surveyed it blew him away.</p> <p>He can attest without any reservation that the men and women in the Kauai Police Department (KPD) are hardworking people, and that KPD is not the worst police department in the country. Having 25 years of service with KPD he has been to many trainings and attended many conferences here in Hawaii and on the mainland. He does not want to judge anyone, but after spending a week with the trainers, in his mind, they could never be part of KPD's training staff and would never be promoted in KPD.</p> <p>The bottom line is the people in KPD are top-notch and have so much potential and he didn't want to turn his back on them and choose the easy option of retiring. Although he felt that his tank was empty before, he now feels reenergized and wants to contribute more so that when he eventually retires the Department his colleagues will not be known as being at the bottom of the list.</p> <p>They will do significantly better because they already are, and although the community and Gallup may not know it, he knows it. He loves his fellow colleagues and wants to be there for them to take to the Department to the next level. He's a person who doesn't want to quit but he cannot to the work by himself, he needs all of them, he needs the community, the union's membership, and KPD's command staff to work together so when the next Gallup survey comes up it will show that the Kauai Police Department is the best department in the nation with the most gains. He doesn't want to have any regrets when he leaves the Department unlike some of his friends who left the Department who wish that they could have done more.</p>

	<p>Chair Yoshida made a comment that the Commission knows that the Kauai Police Department is an excellent Department with good sworn and non-sworn people and is not at the bottom of the list. She then called for testimony.</p> <p><b>Public Testimony</b></p> <p>Bobby Thompson, SHOPO Kauai Chapter Chair, testified on behalf of SHOPO. He thanked Chief Ozaki for stepping up and said he had known AC Ozaki before they worked in the Department and that they've always had a good relationship, like a marriage, because although they would get into it, they would always come back to shake hands. Chief Ozaki is a man of his word, and they will hold him to it because he asked for it. SHOPO looks forward to his leadership because they know he will do everything in his power to get the Department to where it needs to be.</p> <p><b>Mr. Roy Asher</b> stated that he's testifying as a former assistant chief, not a SHOPO representative. On behalf of KPD retirees, he congratulated AC Ozaki on his newly appointed position as the new Deputy Police Chief in the Kauai Police Department. He mentioned that he had the pleasure of working with Ozaki and described him as a great guy who is qualified, capable, and deserving of the position. He shared that on the first Wednesday of each month, KPD retirees would gather to share stories. When it was announced that AC Ozaki was the new deputy chief, his phone was inundated with calls and messages. This overwhelming response was seen as a clear sign that the Department was moving in the right direction and wanted to thank AC Ozaki in-person for his willingness to step up.</p> <p>There being no further testimony, Chair Yoshida moved on to the Employee of the Month recognition.</p>

<b>Employees of the Month August 2024</b>	<p>AC Ozaki called on Hanalei/Kawaihau District Commander Lieutenant Stacy Perreira to address the Employees of the Month for August 2024.</p> <p>Kawaihau/Hanalei District Commander, Lieutenant Stacy Perreira introduced Employees of the Month Officers Roldan Agbayani and Maria Himongala to the Commission. She noted that the nomination was submitted by OIC Eric Higa, who was on duty and could not attend the meeting. OIC Higa wanted to commend the exceptional work of Officers Agbayani and Himongala for their quick thinking and life-saving techniques, which were instrumental in preventing a victim from bleeding out. Their actions exemplify their dedication to public service, public safety, and exceptional skills in emergency medical care.</p> <p>On July 9, 2024, officers were dispatched to Anahola Beach following reports of a 30-year-old male who was stabbed. Upon arrival, Officers Agbayani and Himongala immediately assessed the situation and were able to administer first aid, which played a critical role in stabilizing the victim before emergency medical personnel could arrive. Their ability to remain calm under stress while providing care is a testament to their training, dedication, and commitment to public safety. It is with great admiration to recognize Officers Agbayani and Himongala as the Kauai Police Department's Employees of the Month for August 2024.</p> <p>Lt. Perreira added that she was also at the scene, and everyone who responded played an intricate role in providing care for the victim and the</p>

	<p>apprehension of the suspect. In words of Officer Agbayani, he told her that the incident was a high-profile case for him but the easiest. From Officer Himongala's viewpoint, she recognized that KPD's first aid kits needed improvement so that officers can provide care faster.</p> <p>The Commissioners to part of the recognition to congratulate Officers Agbayani and Himongala. Their actions are a testament to their training, including their ability to apprehend the perpetrator. Too often, people think that police work is to arrest people and give out tickets; it is these types of actions that bring the community's focus back to what police work is all about. A year from now, they are not going to remember the bad days they are going to remember the relationships and the lives they saved.</p> <p>AC Ozaki also took the opportunity to express his gratitude to Officers Agbayani and Himongala for a job well done. He noted that it's such an honor to be able to recognize them for their outstanding work and professionalism. He thanked Officer Agbayani, a military veteran, for his service and Officer Himongala, a mother of a young child who came to work while on maternity leave to help in the records division and in the evidence section, her unwavering dedication to her work as a police officer and her willingness to help goes unnoticed.</p> <p>Chair Yoshida called on Officers Agbayani and Himongala to say a few words. Officer Agbayani expressed his gratitude to everyone for honoring him. He</p>

He mentioned that it was one of the highest-profile cases he was involved in and commended everyone for working seamlessly together. He is deeply honored and shares the honor with the other eleven officers who responded to the call.</p> <p>Officer Himongala thanked everyone for the recognition, especially her beat partner, Officer Agbayani. She mentioned that she worked with almost everyone in the audience at some point in her four years with KPD. She gave a special shout-out to her husband, Officer Russell Himongala, for supporting her career choice.</p> <p>Chair Yoshida called for public testimony.</p> <p><b><u>Public Testimony</u></b></p> <p>Mr. Bruce Hart expressed his gratitude for being able to experience a joyous moment. He shared that he met Officer Himongala for the first time when she was pregnant and working in the records section and is happy to learn that she and her husband, Officer Russell Himongala, had a healthy baby boy. In response to an incident call, in which he, the victim, Officer Himongala, was the responding officer, and from his encounter with her, he can honestly say that she is a person of good character. As a member of the public, the public needs to realize that although the situation is stressful, they behave in a manner that is respectful to the officers who arrive on the scene and not take offense at their questions because they have a job to do and want to help. Whenever he encounters officers of exemplary character, he feels much more comfortable about the situation and how officers handled it. He ended by thanking Officers Agbayani and Himongala.</p>

	<p><b>Ms. Gina Kaulukukui</b> testified that her presence today was on behalf of Life Bridges on what happened on that day to the victim's family. What those officers and people may not know was that the victim's mother died only a few weeks earlier which made it even harder for family by what had happened. What Officers Agbayani and Himongala did, along with all the other responding officers and the people who responded, was it gave the family hope, hope that there would be accountability, and hope that he would survive. Not only did he survive, he thrived and can now come back and be part of the solution which speaks volumes of what KPD officers do day in and day out, not just in life-threatening situations but every single day, whether it's responding to a domestic violence call, a call for an argument or a civil call what all KPD officers like Officers Agbayani and Himongala do is give hope. Thank you.</p> <p><b>Bobby Thompson</b>, SHOPO Chair Kauai Chapter, stated that he knows the victim; he coached and mentored him most of his life. The victim is known to KPD as a problem and has been at the bottom of his barrel for a while. To give a better understand what those officers did, it's much easier for humans to say whatever. However, Officers Agbayani and Himongala made the extra effort to know who the victim was. They did what was needed to ensure he received the best and most professional care. Whether you know the person or not, any officer in KPD will do what is necessary to save a person's life. He ended by expressing his appreciation for Officer Agbayani for his exceptional work and Officer Himongala for always looking for ways to improve procedures and bringing it to the attention of her supervisors for handling.</p> <p>He gave a shout to Officer Russell Himongala for guiding Officers Agbayani and Himongala when they became new police officers. Officer Russell Himongala was their FTO (Field Training Officer) responsible for providing training for newly hired police officers.</p>

<b>Communication</b>	<p><u>Communication dated August 1, 2024, from SHOPO President Robert Cavaco to Police Commission Chair Laurie Yoshida thanking the Chair for providing SHOPO with the Gallup Presentation and an inquiry into learning the Police Commission's next steps.</u></p> <p>Chair Yoshida called for public testimony.</p> <p><u>Testifiers</u>  <b>Brian Silva</b>, SHOPO Kauai Chapter Vice Chair/Detective, testified that he's been with the Department for 23 and half years. His testimony is on trust. According to the results of Gallup's survey, trust doesn't exist in KPD, and that the</p>

Two years ago, SHOPO presented the results of their survey to the Police Commission, and the Commission talked about trust because their opinions were important.</p> <p>A year later, the Commission asked SHOPO to present their results again, which they did. The Commission (again) talked about trust and that their opinions matter. SHOPO wants a broader perspective on the Gallup's survey.</p> <p>He continued to say that the Commission asked SHOPO if they could put their second survey on hold (trust), two years later; faced with the results of the employees' opinions, SHOPO is waiting to hear what comes next. The (inaudible) is not building trust they're asking the Commission to trust the feedback contained in the Gallup's survey came from every corner of the Department and is professional, honest, and in the best interest of KPD.</p> <p>Mr. Silva referred to a complaint the Commission received against a department head alleging severe policy violations and potentially the law, which was admitted to. They (SHOPO) trust that the Commission will treat the employee like others. In the face of overwhelming data that shows KPD has a harmful working environment the employees all agree on the core cause and trust that the Commission will take action that will make a difference. He guarantees that every single KPD employee is looking that the Commission to see if the Commission's actions would dictate whether SHOPO's trust in the Commission was misplaced or not.</p> <p>Mr. Silva stated that as soon as the Gallup's survey was released Chief's Raybuck's did a press release expressing his commit to change and they were later told that Chief Raybuck's intent was to change the work schedule for sworn personnel to 12-hour shifts come October. The Commission needs to know that the change will affect the officers' families because schedules need</p>

	<p>to be changed in terms of getting their kids to school, securing childcare or other care. Yet they were told they had 2 months to modify their schedules.</p> <p>Mr. Silva stated that their not opposing the schedule their rejecting management's approach because they did not take consider the workings of family life and how change would cause distress in trying to figure out what they were going to do on a whim. When asked why so soon, why not give the officers time to plan, the response was because the Gallup poll showed that KPD employees wanted change quickly, without the Commission's direction.</p> <p>The Gallup survey was to prevent bad practices that earned the Department and management dismal results. Mr. Silva stated that this is the fourth Police Commission meeting, in eight months, that Chief Raybuck has missed, that is very telling. When Chief Raybuck made the decision his command staff were not on board, but they later learned what had occurred and he credits AC Ozaki for that.</p> <p>At this point, Chair Yoshida advised Mr. Silva that his three-minute limit was up and asked him if he could wrap.</p> <p>Mr. Silva stated that that they met with AC Ozaki and credits him for his willingness to try to fix the problem. Everyone knows it's about leadership, so a decision needs to be made. Thank you.</p> <p>VC Chair Leslie asked if could ask Mr. Silva a few questions.</p>

	<p>Commissioner Hertog stated that she appreciates his comments, noting that the Commission deserves to be scrutinized, and that they are not going to let him and the officers down. She would like to know, in his own opinion, how much time the officers need to prepare their families for the transition into the new work schedule.</p> <p>At this point, the Deputy County Attorney, Mr. Takamura, interjected and advise Commissioner Hertog that to stick to the agenda item.</p> <p>Chair Yoshida pointed out that the agenda item pertains to contents in the letter from SHOPO regarding the Gallup survey.</p> <p>Commissioner Hertog requested that the item be placed on the next agenda so that she can get a response to her question.</p> <p>VC Leslie said that he wholeheartedly agrees with Mr. Silva on many different aspects but systemically, it is difficult for the Commission because it only meets once a month, and last month is when the Commission was officially given the information as a group, from Gallup. So, up until today, the Commission cannot do anything because it only meets once a month, but they will be discussing it in some aspects of the agenda today. What he's interested in, he cannot ask those questions, so he'll just say, he hears him and are going to act on his words. Commissioner Hong commented the last month's meeting was a wake-up call for him. He been a member of the Police Commission about a year now, didn't realize the shape KPD was in. He senses a shifting of the tide, and he hopes it's within the Commission's purview to continue ride this wave to make a change because being at the bottom of the list, the only way to go is up.</p> <p>Before calling for more testimony, Chair Yoshida took time to remind everyone,</p>

He openly stated his awareness of the October date and emphasized that the decision was made collectively with positive intentions without any ill will.</p> <p>He explained that the decision was influenced by the Gallup survey which indicated KPD officers' eagerness for change. He clarified again that there was no intent to harm the officers, in anyway but rather a lack of communication led to the issue.</p> <p>AC Ozaki confidently highlighted that a meeting was promptly called once the matter was brought to their attention. He encouraged Mr. Silva to continue to be the advocate for the non-sworn employees' and police officers.</p> <p>AC Ozaki stated that they are going address the issue and if it something that shouldn't happen in October, then the command staff can make a recommendation to change the start month all he asks is for them to bring forth any issues sooner rather later so that they can address timely and appropriately. AC Ozaki sincerely apologized and emphatically declared that he takes full responsibility because failing to do so would make him appear cowardly, and he solemnly gave them his word.</p> <p><b>Bobby Thompson</b>, SHOPO Kauai Chapter Chair asked the Commission to understand their frustration and what Mr. Silva said earlier needed to be said and all of it was true. They know that the Commission meets once a month and can only do with the time it has. However, their frustration sat for two years,</p>

	<p>with few or no results since the first survey, then the second survey, which came out the same, if not worse. Every day the police officers put their lives and the lives of their friends at risk. Like Chief Ozaki, he too has a family, and his kids must go to school, and his wife must go to work; coming to work without knowing what will happen next and not getting the results to improve the Department is frustrating.</p> <p>He commended AC Mark Ozaki for reaching out to him when he found out. He doesn't blame AC Ozaki but commends him for taking the blame. Although he was part of the decision, it wasn't him, he's trying to fix the problem and he's trying to help them which is why he took the Deputy Chief's position.</p> <p>Mr. Thompson stated that they look forward to working with him because something needs to be done. They're not trying to pick on anyone or blame anyone, but it's obvious what is happening. The lines of communication are broken, and they haven't sat down for a while but thanks to AC Ozaki they can talk to him and wants to keep his relationship with AC Ozaki.</p> <p>Mr. Thompson shared that SHOPO held their chapter met last night, and much was said about the 12-hour work shift. The discussion wasn't negative; they talked about what they can do, how they can address the different 12-hour schedules, etc. They understand that a date needs to be set, but it will not happen in October; they need to sit down and discuss it.</p> <p>Mr. Thompson stated that everything the membership asks for and receives need to be reflected in a memo of understanding because he wants to make sure everything that was agreed upon is followed. He ended by thanking the Commissioners for their time, noting that he understands the Commission is</p>

	<p>under scrutiny, but so are they.</p> <p><b>Ms. Gina Kaulukukui</b>, KPD's Domestic Violence Intervention Coordinator, testified that she is here as an advocate not for domestic violence victims but for civilians. She's come to these meetings before and always talked about the men and women in blue. She doesn't wear blue but is the backbone of the officers' work; she works in partnership because they are her peers. When the Gallup poll came out, those were voices that needed to be heard because, within KPD, they had no voice in leadership. When they asked for a quick response, they didn't for ask the officers to work 12-hour shifts; they would no longer have a balance between family life and police life.</p> <p>What they asked for was a quick response in the change of leadership which is the demise of the Department. According to the Gallup poll 49% are actively disengaged and 46% are not engaged.</p> <p>She questioned the Commissioners knowledge if they knew the dispatchers are working at a 50% capacity; who's filling in, their supervisors so those dispatchers can get a break after working continuously. Who's asking how they are doing, how their families are doing, nobody. What about after going through a big trauma is anyone offering peer support to those dispatchers and the officers. Were those two officers who were just recognized offered peer support after what they provided; the answer is no. Because peer support is not important to KPD's leadership. Mental health is not important to KPD's leadership. They're seeing new civilian employees in KPD who are making more money than the employees who have been there for 16 years. The Commission needs to know that civilians work because they love their job, and they want change; they want the leadership to be changed because they want to feel valued and appreciated by their leader.</p>

	<p>She doesn't think that the Commission knows her as a domestic violence advocate, when she goes to court that she's been called the c word on multiple occasions, she been sworn at, had her life threatened, her family has been threatened and yet, day after day, like her counterparts the admin assistance, the people in records, the dispatchers who are abused by the public continue to show up for work because they love what they do.</p> <p>She's been with KPD for 16 years and today was the first day because after today, the words she used, if she gets fired, she doesn't care because her chief doesn't care, the leadership in those positions doesn't care. She apologized to everyone for the words she used. Her point being they are not asking the Commission, they're begging the Commission to uphold the standards of conduct that leadership must abide by, that civilians are held accountable to but don't get paid. She asked the Commission to acknowledge the work the civilians in KPD do because they're not just civilians ( she was referred to by an officer just last week) she is a peer, and proudly stands alongside the men and women in blue. Thank you.</p> <p>Chair Yoshida reminded everyone again, that testimony is limited to three minutes.</p> <p><b>Mr. Bruce Hart</b>, testified since the Gallup survey was released, he had hoped for an opportunity to be able to speak publicly to the Commission on the subject. And he knew that if the opportunity came KPD's command officers would be in the room. He shared with the Commission after the Gallup's presentation to the council, he was outside of council's chambers and got to speak to the woman who gave the presentation. He asked her on a scale from 1 to 10, where KPD is at and her response was its not 1 to 10, its 1 to 100 and KPD is currently at one.</p>

	<p>He stated that everyone on the Commission is familiar with him, they know he has come before the Commission going on two years now, and one of his primary complaints was, KPD's performance in his case.</p> <p>He complained in writing and by testimony as to KPD's command. He wants to tell the Commission that he also just gotten up and praise the work of rank and file, he realizes that there are problems with KPD command, it is not about condemnation it's about recognizing the problem.</p> <p>He is not scraping KPD when Chief Raybuck came on board one of the first things he said to him was he that he has a heart for all the officers in KPD. If the Commission remembers when he gave testimony for the first before the Commission, he said basically the same that he has respect for the officers and that he knows many of the officers and some of them have become his friends and they are still his friends, but it has been a difficult struggle to maintain those friendships while at the same time criticizing, constructive criticism especially as a member of the public as a personal issue trying to set aside the personal side and focus on bettering KPD. He said it to Chief Raybuck that he wants to see KPD be the best police department of its size in the nation. He still has the heart, and as a member of public he would like to offer his help as he's always had. Thank you.</p> <p><b>Emergency Services Dispatcher Christina Chong-Tim</b> said that she's been with KPD for eighteen years and wanted to share their perspective on what they've been going through for the past couple of years. She mentioned that KPD recently celebrated National Dispatchers Week, and it was revealed then that they were short-staffed. Ideally, there should be 21 dispatchers, but they have only 9 which leads to many 12-hour shifts. Most dispatchers are mothers who</p>

Despite of that, they are dedicated to their job and the community.</p> <p>Ms. Chong-Tim mentioned that the administrative staff checks on them, but Chief's visits have been rare in the past few years with the most recent one occurring after the release of the Gallup poll and offered to buy them coffee. This raised questions about the Chief's appreciation for the dispatchers and how much they are valued in the organization.</p> <p><b>Dispatcher Johanna Malama-Gomes Dumapit</b> has been in dispatch for four years. As far as the Gallup survey, she wanted to speak up as a co-worker who has been working with KPD officers during this time. It's been sad to see the morale go down, not in just dispatch but for the officers as well. The officers feel that they are not listened to and not being treated as they should be. She has friends who are officers who love their job but are finding it difficult to come to work which is sad; dispatchers come to work because they love their job and as Ms. Kaulukukui said earlier, they show up because they love their job. It's sad when you go to dispatch and see some of the dispatchers completely drained which comes down to them not being listened to. If they bring up issues it would go to the higher ups, then goes nowhere. Most of them feel that when they bring something up, they don't get taken seriously – their just complaining again, so they don't speak up because they don't want people looking down at them.</p> <p>A lot them spoke up during the survey because the job they do is draining and most of them are moms, and if not a mom, they have families at home that they must take care of and attend to but cannot because they're at work all the time. They gave suggestions on hiring more staff or raising their pay, again, it feels like they are not being listened to, so they are struggling along. When someone</p>

	<p>is out sick or on vacation dispatch is down to seven dispatchers. She has a 9-year-old daughter at home, who is active in sports and in school events and it's frustrating for her to not be able to be there in her prime years. She loves her job and loves her co-workers, and she hopes that action will be taken for the officers, dispatchers and civilian workers regarding the survey results for change to come. Thank you.</p> <p>Ms. Chong-Tim added that with everything going on to address change where it's needed, people should focus on dispatchers' mental health because they work 12-hour shifts. Twelve hours of hearing someone complain and still having to deal with their own problems at home is beginning to affect dispatchers mentally at home and at work.</p> <p>Commissioner Hertog stated that she didn't know where to begin. She doesn't want any of the civilian workers who are peers to the officers to feel unappreciated and that goes for Ms. Kaulukui, in her capacity. The Commission knows that there is a lack of dispatchers and wishes that they could get them a pay raise and clone a couple of the dispatchers because it's such a difficult job to do and recruiting is just as difficult.</p> <p>If they've been neglectful in getting the dispatchers the mental health resources that they need, then something needs to be done. Working 12-hour shifts and having to hear someone who is at their worst or suicidal can get overwhelming. Dispatchers are the first line of defense for officers and for the public members, so following up with the dispatchers and everyone else in the Department, to see what type of mental health resources they need is essential. Dispatchers may need to talk to a chaplain or mental health professional, which is not much, but she wants them to know that the Commission hears them and appreciates what they do daily. Dispatchers are the Department's unsung heroes, and to</p>

	<p>only recognize them once a year is wrong because they should be recognized daily, including all civilian employees, because they are the backbone of KPD.</p> <p>VC Leslie stated that he could never have gone on with his career without non-sworn personnel in records and in dispatch and he cannot say how often he would he sit in dispatch watch the screen and was amazed by all the multi-tasking of what was going on. He could never do it. He will ask at the next Police Commission meeting to have Chief Raybuck come back and give the Commission an action plan on how he plans to solve the issue. Additionally, he like the Department and the Chief's input to help the Chief to develop a plan; he wants answers that go beyond we plan on recruiting, he needs to know what it all means.</p> <p>AC Ozaki said he wants all the dispatchers and all non-sworn to know they are genuinely appreciated and apologizes for making them feel they are not recognized and appreciated.</p> <p>Being a dispatcher is a 24/7 job and when he became an officer, he didn't appreciate for non-sworn until he worked in the Administrative and Technical bureau where most of the staff are non-sworn. Making half of what police officers make and still be committed to their work is very telling of their dedication to their jobs and that management needs to show more appreciation for all the non-sworn in the Kauai Police Department every day.</p> <p>AC Ozaki encouraged the dispatchers to continue making suggestions, emphasizing that he would commit to listening to them.</p> <p>Chair Yoshida commented that she agrees with everyone's sentiments that the dispatchers and all non-sworn personnel are an integral part of the Department and are deeply appreciated. She shared that during the recognition of the dispatchers at a previous commission meeting some of the dispatchers could</p>

	<p>not attend the recognition because they had to work so she visited dispatchers at the Department to express her appreciation on behalf of the Commission. Chair Yoshida also stated that because not all their suggestions can be considered getting a response back from the Chief and his assistant chiefs on what suggestion they can or cannot consider will a great step in the right direction because communication is the key.</p> <p><b>Mr. Roy Asher</b> testified that he was police officer in the Kauai Police Department for 46 years and for the last few years as SHOPO's business agent. The Kauai Police Department in its history only had eight chiefs and he worked for five of the chiefs. He doesn't need a survey to tell him that the Department is broken, he's witnessed it and seen its demise. It all starts with the leadership, and it needs to change. He is here to tell the Commission that it is within the Commission's power. Out of the five chiefs he had worked for, two were removed. No one in sitting in the room was there when their removal occurred, but two of the chiefs were removed, and again the Police Commission have the ability as it sees fit. The average tenure of a police chief is three years, and he (Chief Raybuck) is well past that. It's not fair to the men and women sworn or non-sworn to work in those conditions. Currently, this is the worst conditions he is witnessing.</p> <p>VC Leslie asked Mr. Asher if the three years he was referring to be the national average to which Mr. Asher replied yes.</p> <p><b>Prosecuting Attorney Rebecca Like</b> testified that she wanted to weigh in and was glad she attended last month's meeting. What was apparent to her or really stood out was that there seemed to be a lot of fear among the sworn and non-sworn to come forward and say things because there seemed to be a legitimate culture of retaliation in the Police Department coming from the top. She looked through their reports that they get, and they are unable to pursue cases because of the mass exodus of officers occurring. Public safety is compromised because they are losing good officers because of a failure in leadership within the Department.</p> <p>She doesn't understand all the issues regarding increasing pay scale for dispatch, an issue she has complaint about for years. She calls dispatch all the time, she drives in her car a lot and if she sees a crash or sees something that needs to be called in, often but on multiple occasions that had to be put on hold for 5 to 7 minutes. She's not saying it's the fault of the dispatcher, it's the fault of the police department failure to prioritize the first responders. She is grateful that Gallup came in and gave them information. She's just going to say it, and maybe she shouldn't but, the Chief has a very prominent parking spot and when she comes in the morning she is surprised when his vehicle is there. She's not surprised that the Chief is not present today. She commended Mark for stepping up, it's like night and day working with Mark and working with the Chief. Mark is responsive, kind, has the emotional intelligence and cultural competency.</p> <p>She gets fiery and Mark would be like Rebecca, let's sit down and talk about it, that contrasts with just no response until it becomes a huge conflict at some point because there is no follow-up done. She just wanted to express that she is committed to coming to the meetings and weigh in on what's going on. She's glad that officers felt comfortable to come forward to say something because she thinks that they were nervous to do so.</p>

AC Ozaki called on Police Captain Rod Green to address the Field Operations Division Report.</p> <p>Field Operations Division Report. Captain Rod Green reported on four major incidents that occurred in the month of July 2024.</p> <p>On July 11, 2024, an aviation accident involving a helicopter occurred when the helicopter broke apart while in the air and the helicopter fell into the ocean approximately 1-2 miles offshore near Hanakoa Falls. The investigation revealed that three people were involved in the crash. One of the passengers (decedent) was recovered by fire and rescue personnel and brought to Hanalei Pier, then turned over to the Kauai Police Department personnel and subsequently transported to Wilcox Hospital. The other two passengers were not found. CID detectives responded to the scene and took over the investigation.</p> <p>On July 9, 2024, officers responded to Anahola Beach for a report of a 30-year male who was stabbed in the chest. A female suspect was identified and apprehended. The male victim sustained life threatening injuries and was transported to Wilcox Hospital for medical treatment and was admitted for a tracheal deviation and two collapsed lungs. CID detectives are investigating.</p> <p>On July 15, 2024, officers responded to Moi Road in Hanapepe for a brush fire that initiated behind Hawaiian Homes on the Gay and Robinson land. The fire</p>

	<p>consumed approximately 30 acres, and it appeared that firefighters may have had fire under control. At approximately 1423 hours, officers were called back to the scene as the fire escalated and started to spread to due increased wind and moving in a southwest direction towards Kaumakani camp where officers expeditiously began to evacuate residents living in the Kaumakani village and closed down Kaumuallii Highway. Overall, the fire consumed over 1,000 acres and disrupted telecommunications and power for an extended period. No injuries or fatalities were reported.</p> <p>On July 18, 2024, officers responded to a brushfire near Kokee Road which was later classified as arson. The fire affected a large area of state land and spread northeast towards Waimea Canyon Drive. Multiple fire units were deployed, including Crash Fire personnel and Air 1 and worked to contain the fire for four days. The case remains under investigation.</p> <p>Additionally, Captain Green reported that a brush fire was currently occurring and by the last report the fire was 20% contained. **MAJOR INCIDENTS**

**Unattended Death:**

On August 19, 2024, Officers responded to a residence in the Hanalei district for a reported Unattended Death. Upon arrival, the victim was observed in the residence highly decomposed and unidentifiable to responding officers. The victim was found by a cousin who last saw the victim approximately 7 days prior. The victim was identified as a 58-year-old male who had no known medical conditions based on the circumstances and the state of decomposition, CID responded to the scene for continued investigation.

**Arson:**

On August 20, 2024, Officers responded to the area of 5031 Menehune Rd, Waimea, regarding a reported fire. Approximately 2,500 square feet of grass was burned. During the investigation, incendiary items were found in the burned area and later submitted into evidence. CID was notified. No suspect(s) have been identified at this time.

**Misc Pub Medical (Overdose):**

On August 21, 2024, Officers responded to a medical call of a female who possibly overdosed on illegal narcotics. Upon arriving on scene, officers observed an unresponsive female. Officers began CPR and administered a total of 3 Narcan's until EMT arrived and continued CPR. The victim was transported to Wilcox Hospital. Drugs and paraphernalia were observed and recovered from the scene and turned into evidence. At the time of the incident, the victim was in critical condition.

**Brush Fire:**

On August 22, 2024, police responded an area in Anahola across the Whalers General Store near SMM 14 Kuhio Hwy. for a reported brush fire. Fire units responded and subsequently Air 1 and 2 were activated. The area(s) affected appeared to be heavy brush and unoccupied land south of Hokualele Rd. just north of (north) Kealia Rd. KEMA was activated at Level II. Kauai Fire Dept. gained ground access to the area at the west end cul-de-sac at Hokualele Rd. The amount of damage is unknown and there were no evacuations. The brush fire was active for several days and the cause of the fire has not yet been determined.

**Missing Person:**

On August 30th, 2024, Officers responded to a welfare check for a female visitor (30 YOF from Oregon), who was overdue from a hike on the west side of the island. After checks were made with no findings, Officers located the subject's vehicle at the Awaawapuhi Trailhead at 0713 hours. At 1155 hours, the visitor was found on Kokee Road by DLNR. The hiker lost her way after her flashlight died but managed to locate the roadway at first light. The visitor declined medical attention reporting only minor scratches. No further action was taken.

### **Community Activities and Involvement:**

Over the past several years, officers have enhanced their patrols along the bike path by incorporating periodic beat checks and utilizing ATV's approximately 2 to 3 times per week to maintain a strong and visible officer presence. This pro-active approach directly addresses the history of complaints received around the bike path.

Since 2017, officers have responded to a total of 248 calls for service along the bike path, covering a range of incidents including welfare checks, medical emergencies, family disputes, domestic issues, and drug-related incidents. Thanks to these weekly targeted efforts, calls for service along the bike path have decreased by as much as 40%.

**MAJOR INCIDENTS / NOTABLE HIGHLIGHTS:**

**WATER RELATED DEATH:**

On August 24, 2024, a 50-year-old male resident was swept out into the ocean located near the Marine Camp in Wailua, as witnessed by his family. A multi-day search was conducted by the KFD, USCG, KPD, DOCARE, and KSAR, however, the missing person was not located. The investigation remains ongoing.
