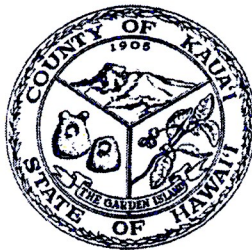

**RE: 2016 COUNTY OF KAUA'I LOBBYIST REGISTRATION**

Ordinance No. 999, Relating to the Registration of Lobbyists was adopted by the Council of the County of Kaua'i on second and final reading on March 23, 2016 and approved by the Mayor on March 30, 2016. Pursuant to Ordinance No. 999, all lobbyists must file a Lobbyist Registration Statement with the Office of the County Clerk, as early as possible, but no later than five (5) days after engaging in lobbying. Lobbyists must also file a Lobbyist Contributions & Expenditures Statement on or before January 31<sup>st</sup> of each year, which shall cover the period from January 1<sup>st</sup> through December 31<sup>st</sup> of the previous year.


