A BILL FOR AN ORDINANCE APPROVING A COLLECTIVE BARGAINING AGREEMENT FOR BARGAINING UNIT 12 BETWEEN JULY 1, 2021 AND JUNE 30, 2025

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAI'I:

SECTION 1. Sec. 19.13.B of the Charter of the County of Kaua'i, as amended ("Charter") provides that any contract or lease requiring the payment of funds from appropriations of more than one fiscal year shall be approved by ordinance.

As such, the following cost items for Bargaining Unit ("BU") 12 under Hawai'i Revised Statutes ("HRS") §89-6 are hereby approved for the period of July 1, 2021 through June 30, 2025:

BU-12:

- A. Effective July 1, 2021:
 - Continue step movement plan;
- B. Effective July 1, 2022:
 - Continue step movement plan; and
 - 5.00% across the board (ATB) salary increase;
- C. Effective July 1, 2023:
 - Continue step movement plan; and
 - 5.00% across the board (ATB) salary increase;
- D. Effective July 1, 2024:
 - Continue step movement plan;
 - 5.00% across the board (ATB) salary increase; and
 - All Unit 12 employees on salary ranges PO-7 to PO-15 shall receive a one-time lump sum bonus as follows:

If any provisions of this Ordinance or the application thereof to any persons or circumstance are held invalid, the invalidity does not affect other provisions or applications of the Ordinance which can be given effect without the invalid provisions or application and, to this end, the provisions of this Ordinance are severable.

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAI'I:

SECTION 1. Sec. 19.13.B of the Charter of the County of Kaua'i, as amended ("Charter") provides that any contract or lease requiring the payment of funds from appropriations of more than one fiscal year shall be approved by ordinance.

As such, the following cost items for Bargaining Unit ("BU") 15 under Hawai'i Revised Statutes ("HRS") §89-6 are hereby approved for the period of July 1, 2021 through June 30, 2025:

BU-15:

A. Effective July 1, 2021:

- Continue step movement plan; and
- All Unit 15 employees employed as of June 30, 2021 and continued to be employed as of July 1, 2021 shall receive a one percent (1%) one-time lump sum payment prorated by their full-time equivalency (FTE) based on their June 30, 2021 annual pay;
- B. Effective July 1, 2022:
 - Continue step movement plan; and
 - 3.00% across the board (ATB) salary increase;
- C. Effective July 1, 2023:
 - Continue step movement plan; and
 - 4.00% across the board (ATB) salary increase;
- D. Effective July 1, 2024:
 - Continue step movement plan; and
 - 4.00% across the board (ATB) salary increase.
