A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2024-897, AS AMENDED, RELATING TO THE CAPITAL BUDGET OF THE COUNTY OF KAUAI, STATE OF HAWAII, FOR THE FISCAL YEAR JULY 1, 2024 THROUGH JUNE 30, 2025, BY REVISING THE AMOUNTS ESTIMATED IN THE GENERAL FUND CIP (*Kekaha Faye Park, Waimea Athletic Field, and Hanapēpē Stadium Park – \$1,650,000.00*)

This Bill proposes to appropriate \$1,650,000.00 in matching funds from the Islandwide Playcourt Resurfacing account for the purpose of resurfacing work at Kekaha Faye Park, Waimea Athletic Field, and Hanapēpē Stadium Park as the County match to the State appropriation as amended by Act 230, Session Laws of Hawai'i (SLH) 2024.

**A BILL FOR AN ORDINANCE AMENDING ORDINANCE NO. B-2024-897,
AS AMENDED, RELATING TO THE CAPITAL BUDGET OF
THE COUNTY OF KAUA'I, STATE OF HAWAI'I, FOR THE FISCAL YEAR
JULY 1, 2024 THROUGH JUNE 30, 2025, BY REVISING THE AMOUNTS
ESTIMATED IN THE GENERAL FUND CIP**

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAI'I:

SECTION 1. That pursuant to Sections 19.07B and 19.10A of the Charter of the County of Kaua'i, as amended, Ordinance No. B-2024-897, as amended, relating to the Capital Budget of the County of Kaua'i, State of Hawai'i, for the Fiscal Year July 1, 2024 through June 30, 2025, be hereby amended as follows:

The sum of up to \$1,650,000.00 by revising the amounts estimated in the General Fund CIP from the following account:

Islandwide Playcourt Resurfacing R20010 [\$1,650,000]

Be and is hereby appropriated for the following purpose:

Kekaha Faye Park, Waimea Athletic Field, and Hanapēpē Stadium Park Resurfacing (County Match to State Appropriation as amended by Act 230, SLH 2024) NEW \$1,650,000

SECTION 2. This Ordinance shall take effect upon its approval.
