	Chair Chahanovich stated that being that today is Commissioner Pacheco's last meeting she wanted to thank him for his support, leadership, and guidance throughout the years. She shared that when she became Chair, Commissioner Pacheco made her feel comfortable and gave her his unwavering support. She will miss him and wished him the best.	
	Commissioner Pacheco stated that although his tenure on the Fire Commission is up it is not a goodbye. He is confident that the Fire Commission will continue to do excellent work and that the Fire Department will continue to move in a positive direction. He noted that as a Fire Commissioner what was a revelation for him, was going through the hiring process not once but twice, and that the experience only strengthened his trust and bond with his fellow Fire Commissioners. 	Reporting on behalf of Fire Chief Michael Gibson was Deputy Fire Chief Roger Mills. Deputy Fire Chief Roger Mills reported on data reflected the March 2023, Monthly Report highlighting the promotion of Fire Fighter III Reid Tanita to Battalion Chief, the promotion of two (2) Firefighters III's in the Prevention Bureau, the promotion of a Firefighter II to Hazmat Specialist at the Kaikea Fire Station. The Department's recruitment interviews were completed – KFD is looking to hire seven (7) qualified candidates. Estimated start date for the 32 nd Recruit Class is April 16, 2023. The 32 nd Recruit Class will consist of four (4) firefighters from the Līhu'e airport crash fire, one recruit from the Pacific Missile Range Facility, bid for the pilot/maintenance contract is progress, the State of Hawai'i is constructing an RFP emergency ambulance service for Kauai and the rest of the state, invitation for bid for two (2) new fire engines will be posted soon, overhaul maintenance for Air1 turbine is currently in progress, the Mayor's administration is supporting KFD's efforts to conduct major repairs on the Department's fire engines, replacement for Truck #6 is due July 2023, meeting with the architect and DOTA LIH regarding helicopter hanger environmental assessment and lease agreement is pending, FY 2024 budget request will includes a recuse three (3), truck #5 and truck #8. Chair Chahanovich sought a motion to receive the Chief's Monthly Reports for February and March 2023.	There was a motion by Commissioner Pacheco to receive Fire Chief Michael Gibson's Monthly Reports for the months of February and March 2023, for the record. Commissioner Garces seconded the motion. 	the authority to do so without tying his increase to an evaluation.	
	Chair Chahanovich stated that evaluations are important and is usually tied to whether an	
	salary increase is warranted or not warranted. She is not a fan of giving the Chief an	
	increase through 2025. Vice Chair Yama agreed and stated that he passionately believes in	
	a person's performance grade.	
	Commissioner Pacheco noted that Fire Chief Gibson's job performance has been stellar	
	since becoming the Fire Chief for the Kauai Fire Department and although no one is	
	perfect he believes that FC Gibson deserves a 5% increase at this point and being that	
	both he and Commissioner Martinez is terming out the new Commissioners along with the	
	current Commissioners can decide on the next path in terms of any future increases.	
	Ms. Ching stated that it is up to the Fire Commission on when it would like to entertain	
	another increase for Fire Chief Gibson as reflected in Salary Resolution 2022-1.
