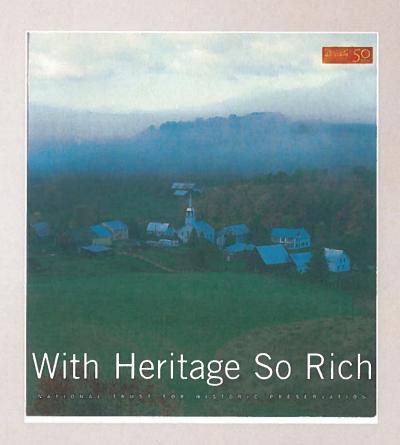

HISTORY, POWERS, AND DUTIES

NATIONAL HISTORIC PRESERVATION ACT OF 1966

In 1965, Lyndon B. Johnson recognized the issue of historic preservation, and convened the Special Committee on Historic Preservation



REPORT OF THE SPECIAL COMMITTEE

Out of the turbulence of building, tearing down and rebuilding the face of America, more and more Americans have come to realize that as the future replaces the past, it destroys much of the physical evidence of the past.

If it can be said that there is a new awakening of interest in the preservation of our cultural and architectural heritage, it must be added that never was the need for it greater.

• The previously existing National Park Service's Historic American Buildings Survey ("HABS") documented 12,000 historic places in the United States

By 1966, many of the places listed in the HABS had been destroyed or damaged beyond repair.

The Special Committee noted that HABS looked like a "death mask of America" with many places only existing in pictures.

In a review of the architectural landmarks recorded in HABS and HABSI some unhappy statistics emerge. It is safe to say that in general many of them survive as a death mask of "This was America," an item in a preserved record. In fact, from 25 per cent to 40 per cent are in this category.

To cite specific examples: Charles S. Pope, AIA, of the Western Office of Design and Construction of the National Park Service, a veteran of HABS, reports from San Francisco that of 145 outstanding buildings recorded, only 23 survive; 95 having been destroyed, and 27 hopelessly mutilated. The losses include such major monuments as the beloved "Monkey Block," as the building was known to generations of San Franciscans.



THE NATIONAL HISTORIC PRESERVATION ACT OF 1966 -

CODIFIED AS 16 U.S.C. § 470, RECODIFIED IN 2014 AS 54 U.S.C. § 300101

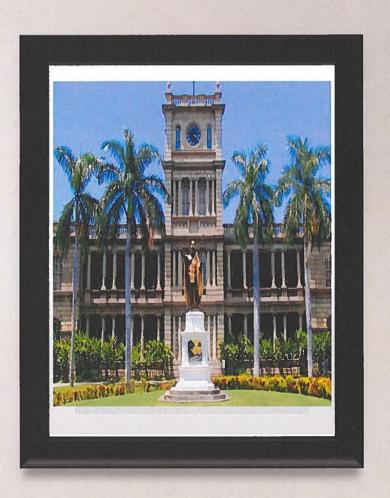
- § 300101 Policy
 - "It is the policy of the Federal Government, in cooperation with other nations and in partnership with States, local governments, Indian tribes, Native Hawaiian organizations, and private organizations and individuals, to —
 - (I) use measures, including financial and technical assistance, to foster conditions under which our modern society and our historic property can exist in productive harmony and fulfill the social, economic, and other requirements of present and future generations;
 - ***
 - (6) assist State and local governments, Indian tribes and Native Hawaiian organizations, and the National Trust to expand and accelerate their historic preservation program and activities."

§ 300307 – HISTORIC PRESERVATION REVIEW COMMISSION

- "In this division, the term 'historic preservation review commission' means a board, council, commission, or other similar collegial body —
 - (I) that is established by State or local legislation ...; and
 - (2) the members of which are appointed by the chief elected official ... from among -
 - (A) professionals in the disciplines of architecture, history, architectural history, planning, prehistoric and historic archeology, folklore, cultural anthropology, curation, conservation, and landscape architecture ...; and
 - (B) other individuals who have demonstrated special interest, experience, or knowledge in history, architecture, or related disciplines"

AT THE STATE LEVEL

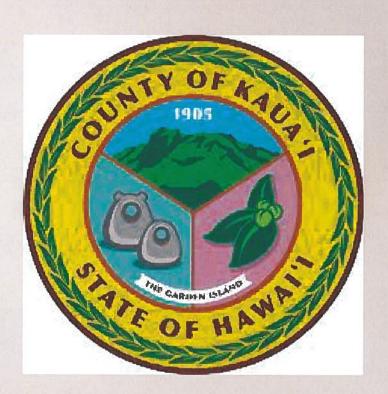
- State Historic Preservation Division HRS § 6E
 - Goal: "conserving and developing the historic and cultural property within the State for the public good," and "to provide leadership in preserving, restoring, and maintaining historic and cultural property" – HRS § 6E-I



POWERS AND DUTIES OF THE KAUA'I HPRC

DEFINED IN THE ORDINANCES

- Title II, Chapter 2, Art. 2-2.9:
- "There shall be a Kaua'i Historic Preservation Review Commission



TITLE IV – COUNTY PLANNING AND LAND DEVELOPMENT

- Chapter 8 Comprehensive Zoning Ordinance
 - Sections 8-14.1 through 8-14.5 define KHPRC's purpose, composition, powers and duties, how meetings will be held, as well as accounting and funding.

POWERS AND DUTIES, § 8-14.3

- · "In order to implement the purposes of this Article, the HPR Commission shall have the power to do any of the following:
 - (a) To adopt criteria, standards, and procedures for the identification of historic resources, and to prepare a Countywide inventory of such.
 - (c) To review and recommend to the State Historic Preservation officer those historic resources which should be for submittal to the keeper of the National Register.
 - (d) To administer the Local Certified Government program of Federal Assistance for historic preservation within the County of Kaua'i.
 - (e) To prepare and implement a comprehensive Countywide Historic Preservation Planning Process, consistent and coordinated with the Statewide Comprehensive Historic Preservation Planning Process.
 - (f) To advise and assist Federal, State and County government agencies in carrying out their historic preservation responsibilities.
 - (h) To assist the Planning Commission to develop standards and guidelines applicable to uses of historic resources and uses proposed within historic districts or neighborhoods, and to otherwise advise the Planning Commission in all matters affecting historic resources.
 - (j) To promulgate rules and regulations pursuant to Hawai'i Revised Statutes Chapter 91 in order to carry out its function in accordance with provisions of this Article."

OBLIGATIONS UNDER § 8-14.4 - MEETINGS

- "(a) The HPR Commission shall meet as necessary, and at least once quarterly.
- (b) Within fifteen (15) days of such meetings, the HPR Commission shall forward comments or recommendations it may have concerning matters referred to it by the Planning Commission to that body for its consideration.
- (c) The HPR Commission shall hold public hearings in accordance with Chapter 91 of the Hawai'i Revised Statutes."

Kaua'i Historic Preservation Review Commission Rules of Practice and Procedure

2.17 Standards of Conduct.

(a) <u>Disclosure of Interest</u>. Whenever a possible direct personal financial interest on any matter pending before the Commission or any of its committees becomes apparent, the affected member shall promptly make a disclosure to the Commission. When a member had made a disclosure of interest and is deemed by the Commission to have as [sic] conflict of interest, such conflict shall apply to all subsequent actions relating to said matter. A member with conflict of interest shall refrain from voting except where the member's vote is required to constitute a quorum to act in which event he shall be permitted to vote.

COMPARE

Charter, Section 20.04

B. Any elected official ... or any member of a board or commission who possesses or acquires such interest as might reasonably tend to create a conflict with such person's duties or authority ... or whose member of such person's immediate family ... is an owner, officer, executive director, or director of an organization in any matter pending before such person shall make full disclosure of the conflict of interest and shall not participate in said matter.

New Version:

2.17 Standards of Conduct.

(a) Disclosure of Interest. Whenever a [possible direct personal financial interest on any matter pending before the] member of the Commission or any of its committees [becomes apparent possesses or acquires such interest as might reasonably tend to create a conflict with such member's duties or authority, or whose member of such person's immediate family possesses or acquires a similar interest, the affected member shall promptly make a disclosure to the Commission. When a member [had] has made a disclosure of interest, they may recuse themselves, or upon motion and affirmative vote of the Commission may be asked to recuse themselves. [and is deemed by the Commission to have as conflict of interest,] S[s]uch conflict shall apply to all subsequent actions relating to said matter. A member with a conflict of interest shall refrain from voting except where the member's vote is required to constitute a quorum to act in which event s/he shall be permitted to vote. Any such conflict shall be disclosed to the Board of Ethics in compliance with its rules.
