BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAI'I:

- SECTION 1. Findings and purpose. The purpose of this ordinance is to appropriate funds for the acquisition of two parcels of vacant land on property in Hanapēpē, Kaua'i, Hawai'i, further identified as TMK: (4) 1-8-008:065 and TMK: (4) 1-8-008:071. The Council finds the following:
- (a) The Hanapēpē parcels are of significant historical and cultural importance to the Filipino and Hanapēpē communities, and labor and plantation history. The parcels mark where the tragic Hanapēpē Massacre of 1924 event began. The battle was a critical moment in the labor movement in Hawai'i that marked a significant struggle between Filipino plantation workers and local authorities.
- (b) The acquisition of the subject lots of record would support the following purposes:
 - 1. Public outdoor recreation and education.
 - 2. Preservation of historic or culturally important land areas and sites,
 - 3. Improving disabled and public access to, and enjoyment of, public land and open space, and
 - 4. Conserving land for open space and scenic values.
- (c) The subject lots are where the Public Access, Open Space, Natural Resources Preservation Fund Commission and community seek to establish a memorial to honor the lives lost and commemorate the event.
- (d) Pursuant to an appraisal conducted by the County of Kaua'i in 2023, TMK: (4) 1-8-008:065 has an appraised value of up to \$685,000.00 and TMK: (4) 1-8-008:071 has an appraised value of up to \$749,000.00.
- (e) Although the subject lots are not currently for sale on the open market, the landowner has committed to sell the properties to the County due to its cultural importance. There is a demonstrable urgency concerning the timing of the acquisition where delaying the action to the subsequent biennial report could result in the landowner no longer being interested in selling the lots or seeking a higher price.

(f) The cost and process for acquiring the subject lot of record is commensurate to the public interest served.

SECTION 2. That pursuant to Sec. 19.07B and Sec. 19.10A of the Charter of the County of Kaua'i, as amended, Ordinance No. B-2024-896 as amended, relating to the Operating Budget of the County of Kaua'i, State of Hawai'i, for the fiscal year July 1, 2024 through June 30, 2025, be hereby amended as follows:
